Coupon Payment

The Securityholder is entitled to receive the payment of the Coupon Amount in the Redemption Currency on the relevant Coupon Payment Date<sub>(i)</sub> in relation to the preceding Coupon Period<sub>(i)</sub>, **provided** that the Securities did not expire early due to the occurrence of an Early Redemption Event **and that no Coupon Amount Default Event** has occurred.

**For the avoidance of doubt**, any payment due in respect of the Coupon Amount in relation to the Early Redemption Payment Date<sub>(j)</sub> shall still be paid out.
