- 2) if the Expiration Price of the Underlying is **lower than the Bonus Level**, the Redemption Amount per Product is calculated according to the following formula:

Scenario 3 If a **Kick In Event has occurred** and

- 2) if the Expiration Price of the Underlying is **lower than the Lower Strike Level**, the Redemption Amount per Product is calculated according to the following formula:
